## 1. Timely Warning Notification

In the event that a situation arises, either on or off campus, that, in the judgment of the Campus President, constitutes an ongoing or continuing threat, a campus wide “timely warning” will be issued. The warning will be issued through the college e-mail system to students, faculty and staff.

Depending on the particular circumstances of the crime, especially in all situations that could pose an immediate threat to the community and individuals, the Campus President may also post a notice on the college’s website at <http://www.antonellicollege.edu> and on the campuses’ physical bulletin boards, providing the Antonelli College community with more immediate notification.

Anyone with information warranting a timely warning should report the circumstances to the Campus President at their location via the phone number on the cover page of this report or in person.

Consider carefully whether your presence at or near this complex while unaccompanied could place you in danger.

Please forward this notice to your colleagues and post it on appropriate bulletin boards in your area. ## 2. Preparation of Disclosure of Crime Statistics

The Antonelli College System Office prepares this report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act.

The full text of this report can be located on our website at <http://www.antonellicollege.edu>. This report is prepared in cooperation with the local law enforcement agencies surrounding our campuses and alternate sites, Campus Presidents and System Office staff. Each entity provides updated information on their educational efforts and programs to comply with the Act.

Campus crime, arrest and referral statistics include those reported to the local police authorities and Campus Presidents.

Each year, an e-mail notification is made to all enrolled students, faculty and staff that provides the website address for accessing this report. Copies of the report may also be obtained from the Office of the Campus President or by calling the phone number indicated on the first page of this report. All prospective employees may obtain a copy of this report in a similar manner.

## 3. How to Report Criminal Offenses

To report a crime, please contact the Campus President in person or at the phone number indicated on the first page of this report, dial 9-1-1 (for emergencies only), private security officers (if maintained by the individual campus), or report it to the local police department. The local police department's contact information is listed on the first page of this report for your convenience.

If the Campus President is not available, please contact his or her designee.

## 4. Voluntary and Confidential Reporting

If you are the victim of a crime and do not want to pursue action within the college system or the criminal justice system, you may still want to consider making a confidential report.

With your permission, the Campus President or his/her designee can file a report on the details of the incident without revealing your identity. The purpose of a confidential report is to comply with your wish to keep the matter confidential, while taking steps to ensure the future safety of yourself and others. With such information, the College can keep an accurate record of the number of incidents involving students, determine where there is a pattern of crime with regard to a particular location, method, or assailant, and alert the campus community to a potential danger. Reports filed in this manner are counted and disclosed in the annual crime statistics for the institution.

The College encourages anyone who is the victim or witness to any crime to promptly report the incident to the police. Because police reports are public records under state law, the local police departments cannot hold reports of crime in confidence. Confidential reports for

purposes of inclusion in the annual disclosure of crime statistics can generally be made to the Campus President or his/her designee.

#### 5. Security and Access

During business hours, the College will be open to students, parents, employees, contractors, guests and invitees. During non-business hours access to all College facilities is by key, if issued, or by admittance by the College staff members. In the case of periods of extended closing, the College will admit only authorized employees or those with prior written approval to facilities.

The college does not maintain residential housing.

Emergencies may necessitate changes or alterations to any posted schedules for campus openings or closures.

Access devices, such as keys and keycards, are issued to employees based on their level of access required. Access devices for computer labs may be provided to students based on enrollment in courses requiring use of labs and collected back after the course is complete. The College's janitorial staff monitors lighting of the college facilities, hallways and stairwells as a part of regular janitorial duties. Additionally, employees are requested to report issues with access (i.e., non-locking or jammed doors) and lighting (malfunctioning lamps) to the college's administration or security guards.

#### 6. Campus Law Enforcement Authority

Antonelli College does not maintain its own police force, but relies on the local police authorities and at some campuses, during limited times, on private security officers.

If private security officers are utilized by the campus, they are required to create, maintain and make available a daily crime log that records criminal incidents and alleged criminal incidents. The Campus President or his/her designee will use such log to track crime data on campus for annual reporting.

Private security officers do not possess the power to make arrests. Criminal incidents are referred to the local police who have jurisdiction on campus.

#### 7. Relations with the Local Police Authority

Antonelli College maintains a close working relationship with the local police authority indicated on the first page of this report. The police staff occasionally works with other federal and state law enforcement agencies. Employees of Antonelli College work closely with the investigative staff at the local police authority when incidents arise that require joint investigative efforts, resources, crime related reports and exchanges of information, as deemed necessary. There are no written memoranda of understanding between the college campuses and the local police authorities.

8. Encouragement of Accurate and Prompt Crime Reporting

As the college does not have its own police department, community members, students, faculty, staff and guests are encouraged to report all crimes and public safety related incidents to the Campus President and/or local police authority in a timely and accurate manner.

In order to ensure inclusion in the crime statistics and aid the College in taking actions to prevent future incidents, you are encouraged to report crimes to the Campus President in addition to reporting them to the local police authority.

9. Pastoral and Professional Counseling and Confidential Crime Reporting

The College does not employ pastoral or professional counselors. If you require a counseling referral, please contact the Dean of Students at your Campus.

10. Security Awareness and Crime Prevention Programs for Students and Employees

During regularly scheduled orientation sessions (which are generally held six times per year), students are informed of campus security policies, annual report availability and ways to access them; are made aware of their responsibility for their own security and the security of others; and, provided with handouts that provide tips on how to protect themselves from sexual assault, theft and other crimes.

Similar information is presented to new employees at the orientation session. Additional information may be presented through bulletin boards.

When time is of the essence, information is released to the Antonelli College Community through timely warning notifications discussed previously in this report.

11. Monitoring Criminal Activity Off Campus

Antonelli College is a commuter institution and does not maintain nor sponsor off-campus living arrangements for its students; nor does it recognize any student organizations or associations with off-campus locations. Therefore, the College does not monitor criminal activity off campus.

12. Using Alcoholic Beverages, Controlled Substances and Illegal Drugs on Campus

The possession, sale or the furnishing of alcohol on Antonelli College campuses is prohibited. Violators of this policy are subject to disciplinary action up to and including administrative withdrawal from the institution for students and termination of employees. In some cases, Campus Presidents may waive this policy for community and educational events. Such waivers must be made in writing.

Antonelli College campuses are drug-free zones. The possession, sale, manufacture, or distribution of any controlled substance or illegal drug is not permitted under both state and federal laws, and is expressly prohibited at the Antonelli College campuses. Violators of this policy will be subject to disciplinary action up to and including administrative withdrawal from the institution for students and termination for employees. The College will further refer such cases to the local police authority for further investigation and prosecution.

### 13. Substance Abuse Education Programs for Students and Employees

Antonelli College has developed a program to prevent the illicit use of drugs and the abuse of alcohol by students and employees. The program provides services related to drug use and abuse including dissemination of informational materials, educational programs, counseling services, referrals and college disciplinary actions.

The Office of the Dean of Students provides an overall coordination of the Substance Abuse Education Programs for the college. These include: alcohol and drug education seminars, conducted annually; bulletin board announcements; referrals to qualified outside parties for counseling; and, disciplinary actions taken by the College.

### 14. Disclosures to Alleged Victims of Crimes of Violence or Non-forcible Sex Offenses

Antonelli College will, upon written request, disclose to the alleged victim of a crime of violence, or a non-forcible sex offense, the results of any disciplinary hearing conducted by the college against the student who is the alleged perpetrator of the crime or offense. If the alleged victim is deceased as a result of the crime or offense, Antonelli College will provide the results of the disciplinary hearing to the victim's next of kin if so requested.

### 15. Emergency Response and Evacuation Procedures

#### 15.1 Emergency Situations Defined

The Campus President or his/her designee will immediately notify the campus community upon confirmation of a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurring on the campus. Such emergencies will include events, such as, but not limited to:

- Outbreak of meningitis, norovirus, or other serious illness
- Approaching tornado, hurricane or other extreme weather conditions
- Earthquake
- Gas leak
- Terrorist incident
- Armed intruder

- Bomb threat
- Civil unrest or rioting
- Explosion

## 15.2 Emergency Situation Notification

In the event of an actual emergency, the campus community will be notified through telephone, e-mail, the college website, and/or other methods as applicable and as determined appropriate by the campus administration. Students should take responsibility for regularly checking their e-mail. In order to receive campus-wide e-mail announcements, students must have a College e-mail account.

For on-campus employees, each campus establishes telephone/oral notification trees that are followed when communicating an emergency. Additionally, Department Chairs notify their faculty who in turn notify students in the classroom.

## 15.3 Emergency Situation Confirmation

The Campus President or the school official acting in his/her absence will determine and confirm such an emergency or situation, relying on the internal information, communications from law enforcement authorities, publicly available information such as the TV and radio announcements and alerts, and other sources as appropriate. The Campus President or designee will then determine whether to issue an emergency alert, whether to communicate it to the entire campus community or a segment thereof, what methods will be used to communicate the alert, and determine the content of the alert. Such decisions will be made based on the potential of the threat to affect the entire campus community or a segment of the campus. The Campus President or designee will continuously assess the situation and issue additional alerts or take additional actions as appropriate.

## 15.4 Emergency Assessment and Responsibility

The Campus President is responsible for initiating the notification systems. Generally, the first responders, such as, Police and Fire authorities will receive the initial notification.

As soon as Antonelli College has confirmed that a significant emergency or dangerous situation exists, it will:



- Take into account the safety of the campus community,
- Determine what information to release about the situation, and,
- Begin the notification process.

The only reason Antonelli College would not immediately issue a notification for a confirmed emergency or dangerous situation is if doing so would compromise efforts to:

- Assist a victim,
- Contain the emergency,
- Respond to the emergency, or
- Otherwise mitigate the emergency. An example of not compromising efforts to mitigate the emergency might include agreeing to a request of local law enforcement or fire department officials.

The individual responsible for carrying out these procedures is the Campus President or his/her designee, or an institution official designated as acting in place of a Campus President.

#### 15.5 Evacuation Procedures

Instructions to evacuate will be issued by the Campus President or his/her designee.

Some incidents may require students and employees to stay in their room and lock doors, windows, turn off air conditioners, heaters and fans, and turn on the radio or television to listen for further instructions.

If an evacuation order is issued, faculty, students and staff are to collect their personal belongings (i.e., purses, wallets, id cards), evacuate quickly but in a calm and orderly fashion to a safe area per posted evacuation routes for their campus area and gather in groups at a designated site outside the building. Generally, such site is the main parking lot of the campus. Only stairs may be used, elevators should not be used. Employees and students should not block access routes for emergency responders and should follow all directions of emergency responders. If necessary, emergency responders will direct employees and students to another site upon evacuation.

Faculty members are responsible for collecting their attendance rosters and verifying complete student evacuations. Department and office supervisors are responsible for verifying complete evacuation of their employees. Names and descriptions of any students or employees unaccounted for must be communicated to the emergency responders immediately.

#### 15.6 Annual Emergency Response Test

Each campus schedules and tests an emergency situation response which includes a complete campus evacuation on an annual basis. Such emergency response tests will be

scheduled in advance; contain drills testing procedural operations, such as, e-mail or phone notification trees; contain an exercise coordinating efforts of the college and first responders; have specific measurable goals, such as, evacuation time; and be followed by thorough assessment of the response test experience.

#### 15.7 Publicizing Emergency Response and Evacuation Procedures

Each campus publicizes its emergency response and evacuation procedures on an annual basis through an e-mail blast to all members of the campus community.

#### 15.8 Record Keeping

Each campus documents its emergency response and evacuation testing by maintain a log that contains a description of the exercise, date, time the test started and ended, and whether the test was announced or unannounced. The Campus President is responsible for documenting such information.

### 16. Preventing and Responding to Sex Offenses

#### 16.1 Sex Offense Prevention Educational Programs

The College educates students about sexual assaults, rape, acquaintance rape, and other forcible and non-forcible sex offenses as a part of the regular orientation program, and through the Office of the Dean of Students where literature on date rape education, risk reduction, and the college response is available.

#### 16.2 What to do if you are a Victim of a Sex Offense

If you are a victim of a sexual assault at Antonelli College Campus, your first priority should be to get to a place of safety. You should then obtain necessary medical treatment. The Campus Administration strongly advocates that a victim of sexual assault report the incident in a timely manner to the local law enforcement authority. Time is a critical factor for evidence collection and preservation.

Filing a police report will:

- Ensure that a victim of sexual assault receives the necessary medical treatment and tests, at no expense to the victim;
- Provide the opportunity for collection of evidence helpful in prosecution, which cannot be obtained later (ideally a victim of sexual assault should not wash, douche, use the toilet, or change clothing prior to a medical/legal exam);
- Assure the victim has access to free, confidential counseling from counselors specifically trained in the area of sexual assault crisis intervention.

#### 16.3 Notifying Law Enforcement Authorities and College Authorities

We strongly advocate that you should report a sex offense to the local police enforcement authority. You should also contact the Campus President to file a report of the offense with the institution, so that the College can take appropriate action that will make the campus community safer.

#### 16.4 Counseling and other Services for Sex Offense Victims

A referral for psychological or pastoral counseling for victims of sex offenses may be obtained through the Office of the Dean of Students.

#### 16.5 Accommodations for Sex Offense Victims

A victim of sex offense may request the College to make modifications to their academic situation, such as, a change in schedule or any other reasonable accommodations. Please do not hesitate to request such accommodations – Antonelli College will provide the best service possible to help you recover from the trauma of a sex offense and to help you continue to be successful in your studies.

#### 16.6 Campus Disciplinary Action Proceedings

The College will conduct an internal inquiry following any accusations of a sex offense committed against its students and take disciplinary action based on the findings of the internal inquiry. The Campus President chairs the inquiry committee and appoints committee members drawn from the campus administration and staff.

Both the accuser and the accused are entitled to an opportunity to have others (i.e., witnesses, parents, or other individuals) present during such a disciplinary proceeding.

Additionally, both the accuser and the accused will be informed of the outcome of any institutional disciplinary proceeding brought alleging a sex offense. Such an outcome will be communicated in writing to both the accuser and the accused, and will disclose the final determination of the College with respect to the alleged sex offense and any sanction that is imposed against the accused party.

The College has no tolerance for perpetrators of sexual offenses and will expel such offenders from the institution through administrative withdrawal (students) or termination (employees).

### 17. Sex Offender Registration Policy

The Campus Sex Crimes Prevention Act (CSCPA) of 2000 is a federal law that provides for the tracking of convicted sex offenders enrolled at, or employed by, institutions of higher education. The CSCPA is an amendment to the Jacob Wetterling Crimes Against Children and Sexually Violent Offender Act. The federal law requires state law enforcement agencies to provide Antonelli College with a list of registered sex offenders who have indicated that they are either enrolled, employed, or carrying on a vocation at Antonelli College.

A list of all registered sex offenders in the state is available from the following state authorities:

The CSCPA further amends the Family Educational Rights and Privacy Act of 1974 (FERPA) to clarify that nothing in the Act can prohibit an educational institution from disclosing information provided to the institution concerning registered sex offenders.
